About Us

We are a democratic, independent, not-for-profit organisation of supporters, committed to strengthening the voice for supporters in the decision making process at our club and strengthening the links between the Club and the community it serves.

We are legally registered and regulated by the Financial Conduct Authority (Registration No. 30743R). This means we can hold assets like any other company. This also means that any money raised or shares bought would belong to all members equally and not held by any individual. The main differences are in the way our Trust is organised, its strategies and the attitude it has towards issues at the Club.

Organisation

A major strength of our Supporters Trust is our constitution. The Financial Conduct Authority regulates us and we must provide annual accounts, which means that we are transparent. Any paid-up members can put themselves forward to be elected to the board of the Trust and the income that the Trust raises is spent according to the members' wishes in line with our registered aims.

The Trust's Attitude

The Supporters Trust is about channelling the passion of supporters into a forward-thinking organisation that looks to the long-term, offering solutions to the Club and the community. On one level, our Supporters Trust will act as the guardian of the future of the Football Club. If we believe that the Club is being run incompetently and not in the interests of the fans, we will not be afraid to criticise. However, we are not here to be relentlessly critical. We are also about helping the club, tapping into the skills and expertise of our membership, offering solutions and not just posing problems.

A lot of things change in football: - Chairmen, Managers and Players but the fans remain so why shouldn't we be involved in the big decisions at the football club?
